The Selectmen expressed disappointment in this delay as the upgrades to the Transfer Station cannot be completed until the compactors are installed. Once they are installed, the Washington environmental Council will be assisting with educating the public on glass recycling, composting and other features that will be added. Jim also met with the representatives from OSHA and Connecticut Fence to complete the installation of fencing.
- **Senior Center:** COVID Vaccination Clinic tomorrow at the senior Center. The use of the sandwich board outside has proven to be very helpful with upcoming events. Jay Hubelbank recommended there be a way for seniors to sign up for the Center's mailing list.
