Town Plan of Conservation and Development

Sustainability

Ms. Payne asked that the Commissioners carefully read the Draft Sustainability report by Milone & MacBroom and be prepared to discuss and provide feedback at the regularly scheduled Conservation Commission Meeting on February 6, 2013. She stated that she would provide this feedback to the Planning Consultants once CC has had the opportunity go over the report together.

Cell Tower Update

Ms. Payne stated that she talked to the First Selectman and was told that Town Counsel is

reviewing some of the legal language in the proposed lease with Homeland Towers for 10 Blackville Road. She noted that there would then be an informational meeting for the Town and a balloon float. She informed the Commission that there is a moratorium on any approvals for this site until March 1, 2013.

Other Business

Stone Wall Ordinance:

The Commissioners agreed that they would move forward and work on this issue.

New Preston Open Space:

Mr. Markert and Mr. Dutton worked on property in December and Ms. Payne suggested that the Commission could possibly schedule another work weekend if there is mild weather.

Knotweed Eradication:

Ms. Payne stated that the eradication of the knotweed is an ongoing process. Mr. Sabin suggested educating property owners along the Shepaug about this invasive species. There was a brief discussion regarding ways to educate the public.

Ms. Payne stated that the Nussbaum Easement has been signed.

Ms. Payne noted that the wind farm has been approved in Canaan, CT.
