# **Update on having Historic District added to Zoning permits:**

The Commission reviewed the permits and was pleased to see that the Historic District was added to the Zoning application to help insure there are no mistakes made when an applicant is going through the permitting process. There was also a brief discussion if the historic District needs to be add to any other permit applications.

#### **Old Business:**

Mr. Hollinger informed the commission that Ms. Locker didn't receive the certified letter that was sent to her. The post office tried to deliver on three separate occasions. The letter was returned to the clerk at Town Hall on November 14, 2019. At which time the clerk emailed Ms. Locker a copy of the Certificate of Appropriateness denial letter and the mail delivery attempts. Ms. Locker emailed the clerk immediately asking about the appeal process. After a discussion regard enforcing regulations the commission can only advise Ms. Locker to contact an attorney to discuss what her rights are in regards to this.

The Commission discussed if a Certificate of Appropriateness should be applied for when something is temporary visible

There were trees cut down expositing the air conditioner units at the Washington Club Hall. The Historic district commission will be writing a letter regarding the visibility of the air conditioner units. The commission would like to know when the air condoners were originally installed.
