Delay of Demolition

Mr. Hollinger went on to state that Mr. Rimsky and Ms. Woodroofe should keep in mind the fact that this proposed ordinance will need to go to a town meeting for approval, and that the document should be complete enough for the Commission to take potential comments from the public into consideration.

Installation of Stone Sculpture on the Grounds of the Rocks, 21 Kirby Road Without Getting COA

Mr. Hollinger asked that the Historic District Commission Clerk, Mr. Buell, provide an update regarding 21 Kirby's unapproved stone gateway. Mr. Buell informed the Commission that he had drafted a violation letter and had sent it via certified mail to the property owners informing them that they must attend a public hearing to discuss this matter and explained that he would keep the Commission updated on their response.

Mr. Hollinger asked the Commission if there was any new business that they would like to discuss. Mr. Buell stated that he would still require resumes from all Commission members for the Certified Local Government application.
