## \* Beach/Boat Launch:

# \* River Walk Park:

Lisa Easter reported that Eagle Electric has not yet been to the Pavilion to do the work previously discussed. She will fill out the necessary paper work with the Building Department and coordinate with the Pavilion Attendant and Groundskeeper to be available for when Eagle can do the work. C.J. Kersten reported the fields are in good shape and the Swanson/Horrigan Tournament went well with a large turnout. Lisa Easter reported that Liz Gugel has notified her that there is a problem with the knobs on the kitchen stove. Liz has offered to try to get replacements at Powerhouse. The refrigerator is rusty in parts and will try to clean it up. There is still an additional refrigerator in the kitchen from the Firemen's Carnival.

#### \* Fireworks:

Ray Reich presented the Commissioners with a preliminary report. The fireworks were cancelled excessively wet conditions at the Shepaug campus. As there was no rain date, tickets will be honored next year and very few or none will be sold for the 2014 show. The sale of car passes was down (804 out of 1100) but VIP passes/donations were up. T-shirt sales were also down. Total income was approximately \$33,145; expenses \$3378. Ray and Mary Anne Greene will compile final figures.
