It's a strong slate of candidates, Jay Hubelbank, Jim Brinton, Michelle Gorra and a few others that are not here tonight. There should be a lot of information passed out at the forum and a system for public written questions to candidates.

that was transferred under the same terms. Then there's a little square at the end of it which is what we're talking about now. This is a piece of the old railroad bed that was deeded to Washington when the railroad went out of business. As of last year, we didn't know that we owned the railroad bed. It was not an issue. There's no use of it for the town. There's no use of this little one-tenth of an acre for use by the town. ROMAC LLC is the owner of basically this whole band now. They must have been all separate parcels so the multiple road numbers. They are paying our attorney

as well as all the fees involved.

Moderator: Any questions? Yes.

R. Schlossberg: Has ROMAC been a good neighbor and free of controversy or

legal issues?

M. Lyon: He has been doing a lot of work on the property along the river.

He's also been very diligent in getting all the proper permits for the work. Eventually as his plan is completed, he'll be doing a lot of planting. The invasive species along the river have been cleaned, regraded, reseeded, and part of the permit is for replanting native

trees along the river.

R. Schlossberg: Are there any issues with the Conservation Commission or Inland

and Waterways with them?

M. Lyon: No, he's gotten all the proper permits through Inland-Wetlands.

R. Schlossberg: I'm Richard Schlossberg of Washington.

M. Greene: May I have your address please sir?

R. Schlossberg: 36 Hifield Drive.

M. Greene: Thank you.

Moderator: Any other questions? I just have one. I understand that the tenth of
