- Resignation of Carrie Rowe from the Sustainability Committee: The Selectmen accepted Carrie Rowe's resignation with thanks for her service as one of the initial members of the Committee.

 He has been actively involved in the River Alliance and similar organizations. The motion passed
 unanimously.

First Selectman's Report: Jim Brinton reported the following:

- Powassan Virus: Jim was notified by the Housatonic Valley Health District, which had been
 notified by the State Department of Health, that there were two confirmed cases of this virus in
 Washington. The virus is transmitted by deer ticks and can be seriously debilitating. At present
 there is no vaccine or treatment. A meeting was held with all Town employees advising the
 need to be vigilant and to take all necessary precautions. An email blast will be sent out
 tomorrow notifying residents with a link to the Center for Disease Control that contains more
 information on the virus.
- **Tunnel Road Bridge:** Work will resume on the bridge following a site visit from the DEEP which concluded that any infractions have been remedied and all levels are acceptable.

OLD BUSINESS:

• **Titan Energy Contract:** At the last Board of Selectmen's meeting a motion was made to renew the contract with Titan Energy for one year. The contract will be reviewed again in December or January of 2024 to determine if the Town would be eligible for a better rate if renewed for a two-year period.
