First Selectman's Report:

- The funding for the Washington Emergency Medical Services Station located at 92 Bee Brook Road was approved at the October 17, 2023 Special Town Meeting. The Committee for the project will move forward with the architects.

Hank served for many years as moderator at Town Meetings and other special meetings; he was also Chairman of the Zoning Commission. He did a great job keeping all meetings in order. - Jim noted the Municipal Election is November 7th and prior to that both the Democratic and Republican Town Committees will submit their list of candidates for the Friday email blast.
- Congratulations to Shepaug Field Hockey and Golf and Soccer (Boys) for each of the teams winning the Berkshire League for the season!

Selectmen's Report:

 Jay Hubelbank mentioned that he, Amanda Reale (Selectmen's Office), and Sheila Anson (Town Clerk) have been working together to update the Town Ordinances and get them on the town's website with a searchable database. There is a budget line item for this project and Jay is waiting for a final proposal. The civic code company submitting an estimate will also include Zoning Regulations. Land Use Departments will be included in this discussion and decision.

- Jay Hubelbank distributed a History of Municipal Solid Waste and Recycling by year and numbers of amounts measured in tons (see attached). In addition to the materials listed, more will be tracked in the future. Composting has gone from two or three bins up to six bins.

 Extend an Invitation to Bid for the construction and installation of pickle ball courts.
