#### **Current Situation - Need**

There currently are no full day child care programs operating in Washington forcing working parents to have to leave town to find child care.

"I live in Washington and work in Washington, my older children go to school in Washington and I have to drive to New Milford back and forth everyday 4 times a day and it is very inconvenient. I would appreciate having a closer day care center for her."

#### **Current Need**



"...I'd like to send my girl to the preschool through the district but have a younger daughter who also needs care .. it seems like a logistical nightmare to even attempt to consider it." -K.C. Washington Community Facebook page 4/2021

"... We would love to attend REACH but the hours do not cover our work day and we don't have coverage for the summer. As remote work is more common than ever, which I feel is bringing more families in, we just need the support structure to keep them!"- B. H. email following survey 11/2021

#### 2021 Survey Data Regarding Daycare

106 respondents - 53 from Washington

- 51 children in our target age
  39 of the 51 attend a licensed child care program outside of our town (76%)

When asked the survey question " If you had access, at a fee you were able to pay for year-round, out-of-home licensed child care for infants to four year olds in Washington Depot, would you consider enrolling one or more of the children in your household in it?"

The respondents answered yes inclusive of the care for 100 children, which includes anticipated future need

There was also just as much interest from Region 12 staff and parents in Roxbury and Bridgewater.



## Proposed Solution-Shepaug Valley Children's Center

**Hours:** 7:30 am - 6:00 pm, year round

Ages Served: 6 weeks - 5 years old

Capacity: 34 - 16 infant/toddler, 18 pre-school

\* Ability to add 19 school aged children during the summer months

**Location:** 11A School Street, Washington Depot - Region 12 Central Office next to Washington Primary School

**Operator:** Non-profit organization

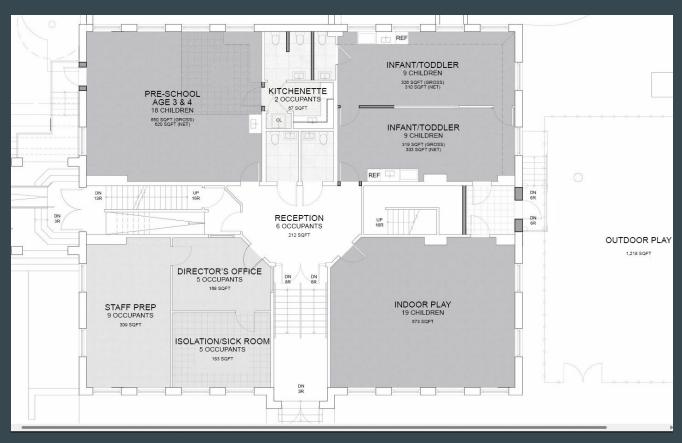

# **Building Renovation Plan-**







#### **Renovation Cost Estimate**

• Estimated cost of construction: \$411,119

Including: protection materials and installation, demolition and carting of interior walls, demolition of metal pan stair, rough carpentry, drywall, dealings, finish carpentry, doors and hardware, glass and mirror, painting, tile walls in bathrooms, vinyl flooring, carpet tile patching, carpet tile patching flooring, plumbing, plumbing fixtures, bath accessories, electrical, HVAC, cabinetry & millwork, exterior fencing, cleaning, door openings and peripheral work, fee, general conditions, insurance & tax

Architect's fees for construction
 Drawings & management:

Environmental Testing: \$2,000

Engineering (if needed): \$2,500

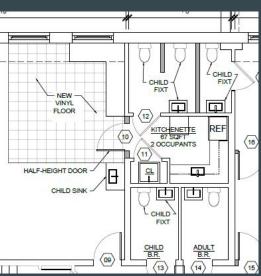

#### **Anticipated Operating Costs**

**Income**: \$429,500- tuition at full capacity (\$300/ wk)

**Expenses**: \$414,705 Cushion of \$14,795

Staff (at full capacity) \$337,655 (no benefits budgeted)

Building / Operations\*- \$62,725 Supplies \$14,325



\*includes: advertising, capital improvements, cleaning-interior, accountant, health consultant, permits, dues, licenses, payroll fees, bank fees, liability insurance, maintenance- exterior & interior, utilities, flood insurance, water testing

- Requesting \$45,000 annual cost from the town to pay for building operations of the program

## Potential ways to pay for Renovation

- Town fund balance transfer
- STEAP grant
- Other state grants
- fundraise
