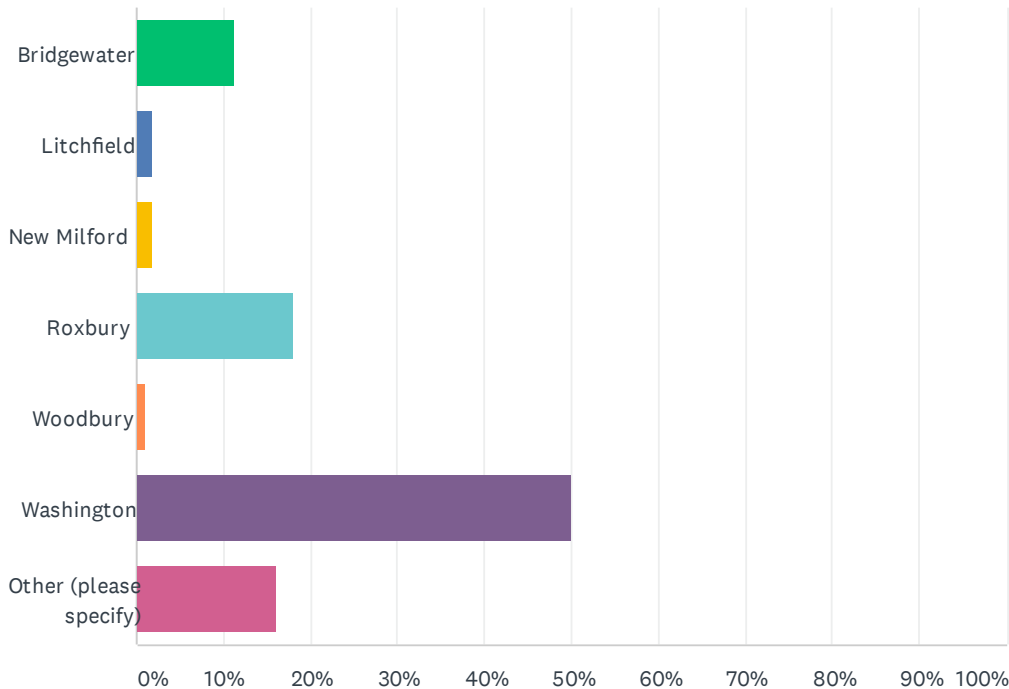

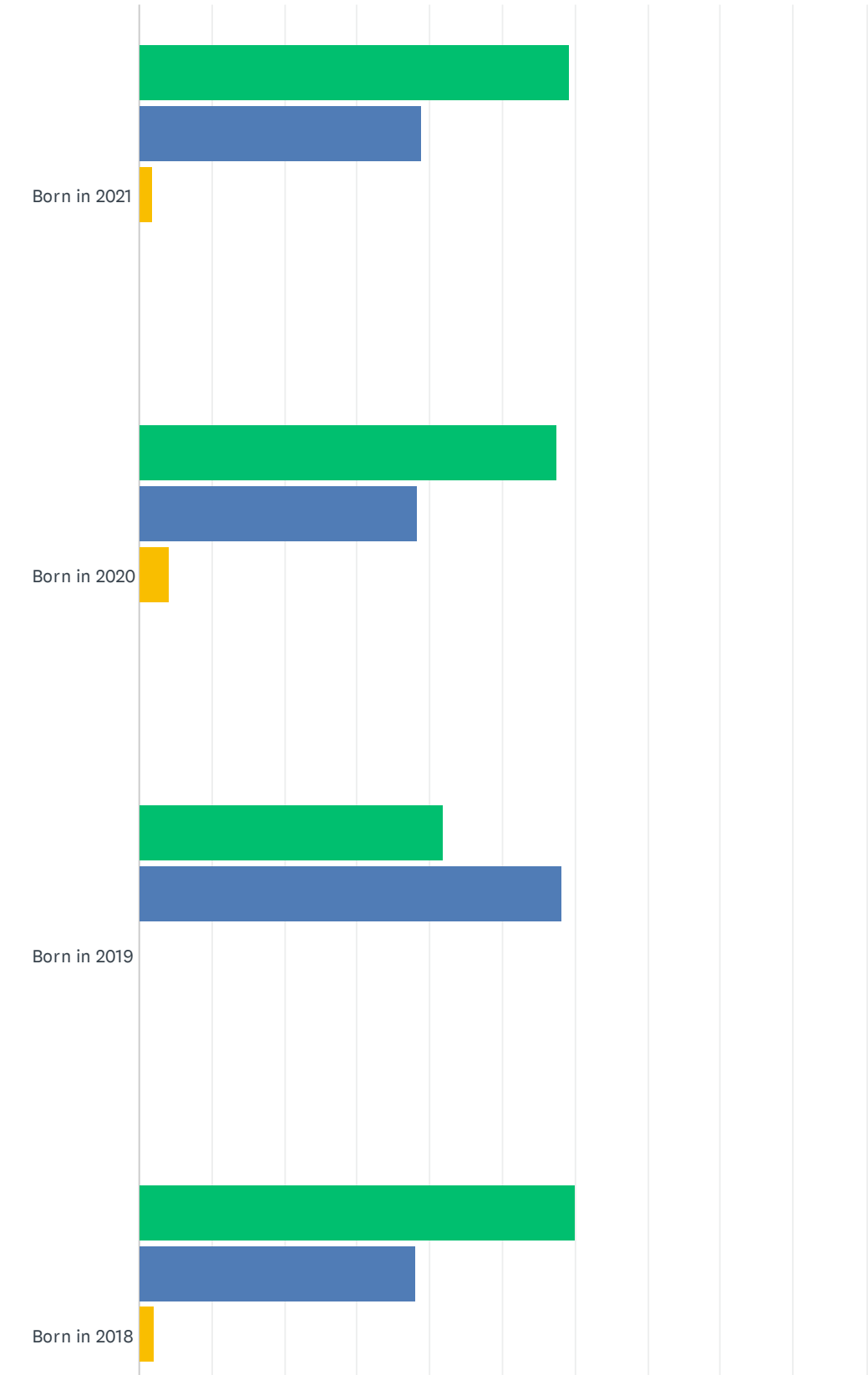

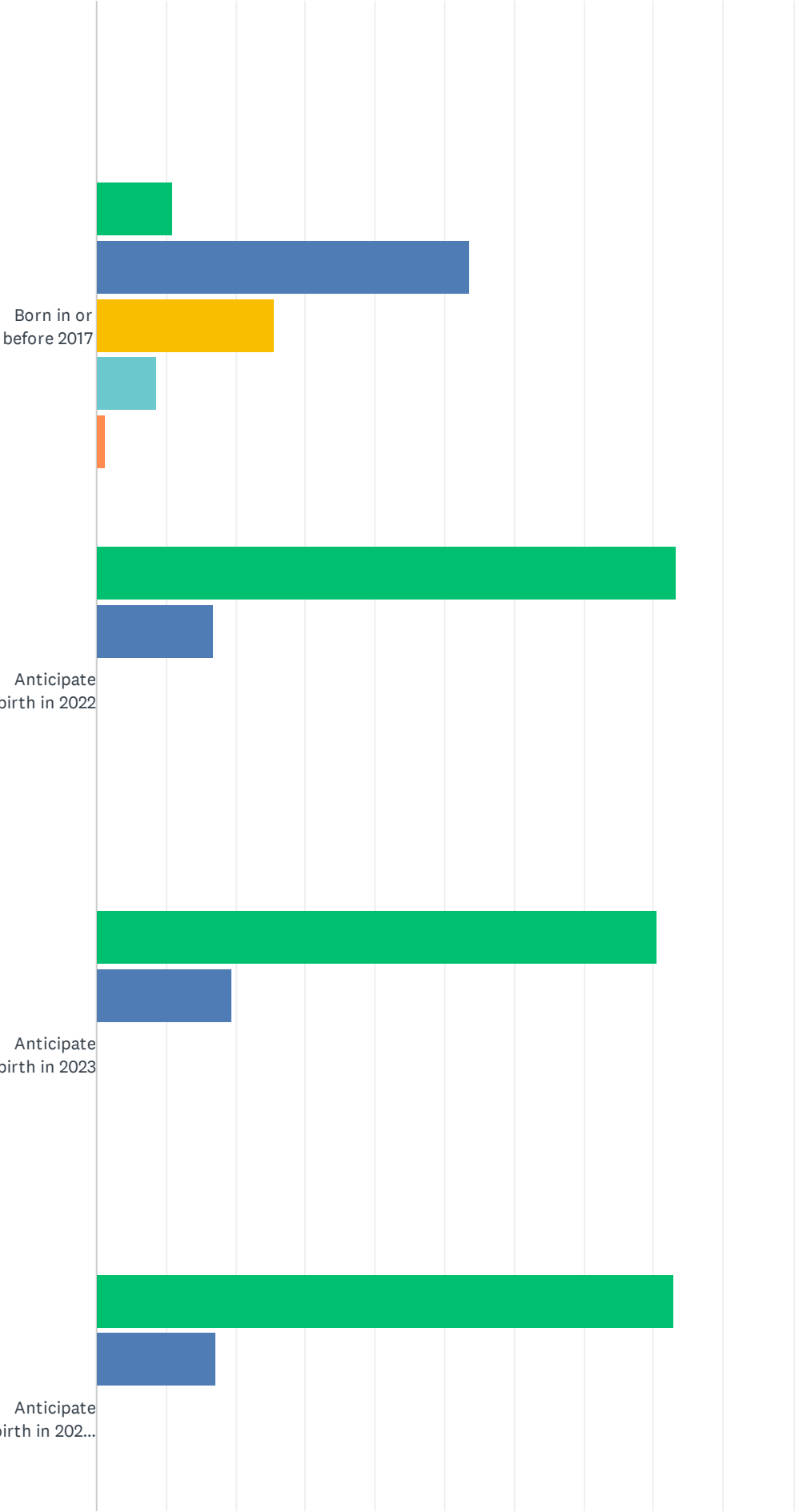

Q2 Please indicate the number of children in your household in each of the following age groups?

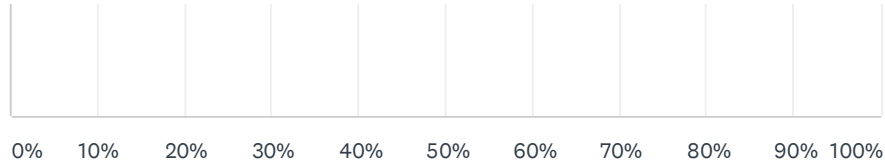

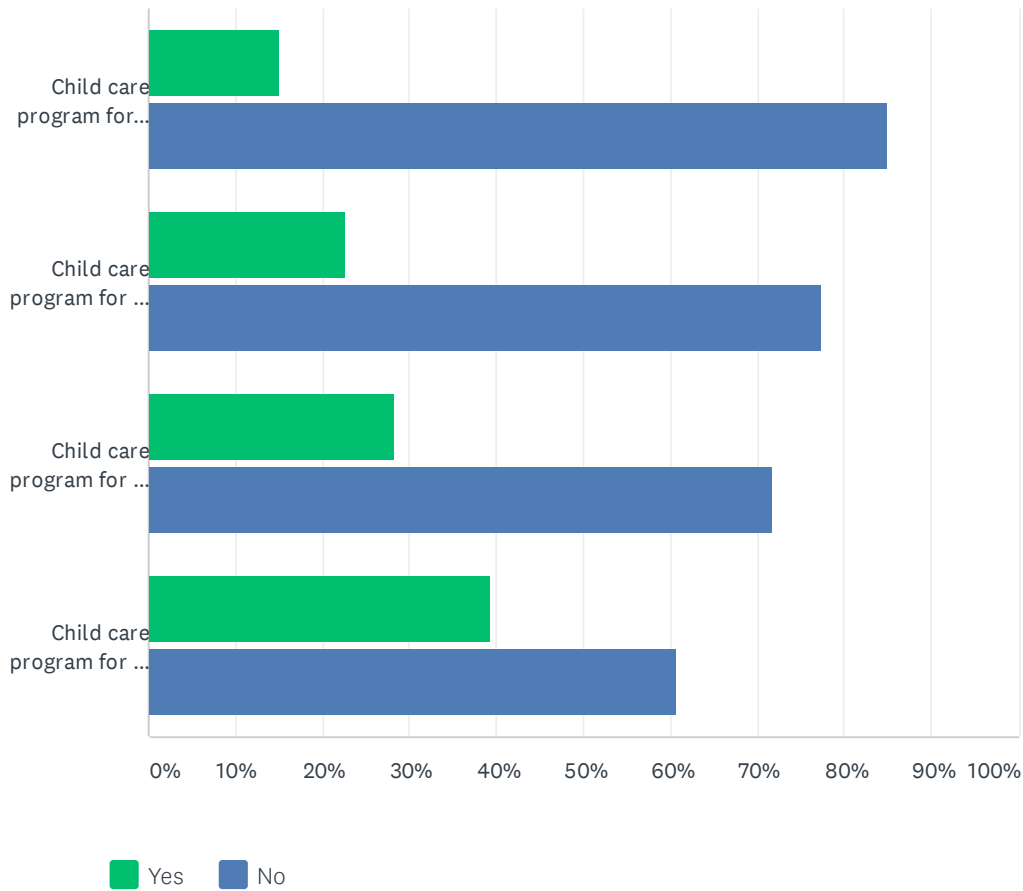

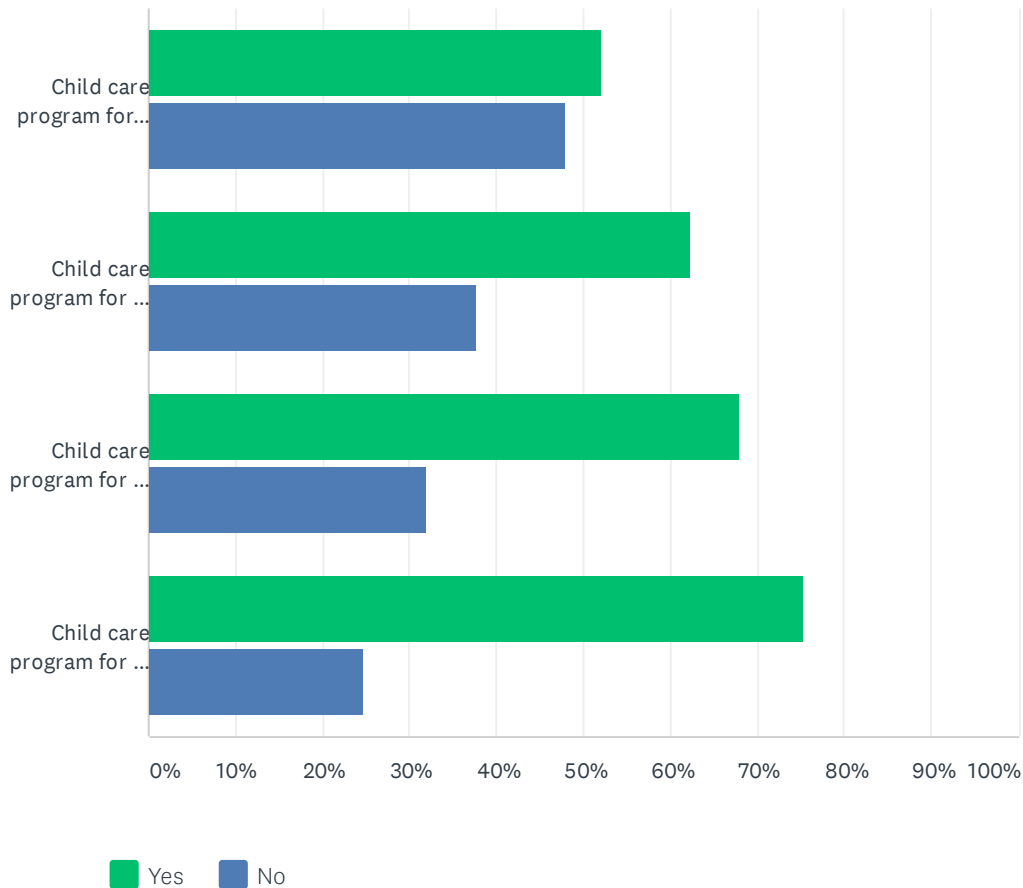

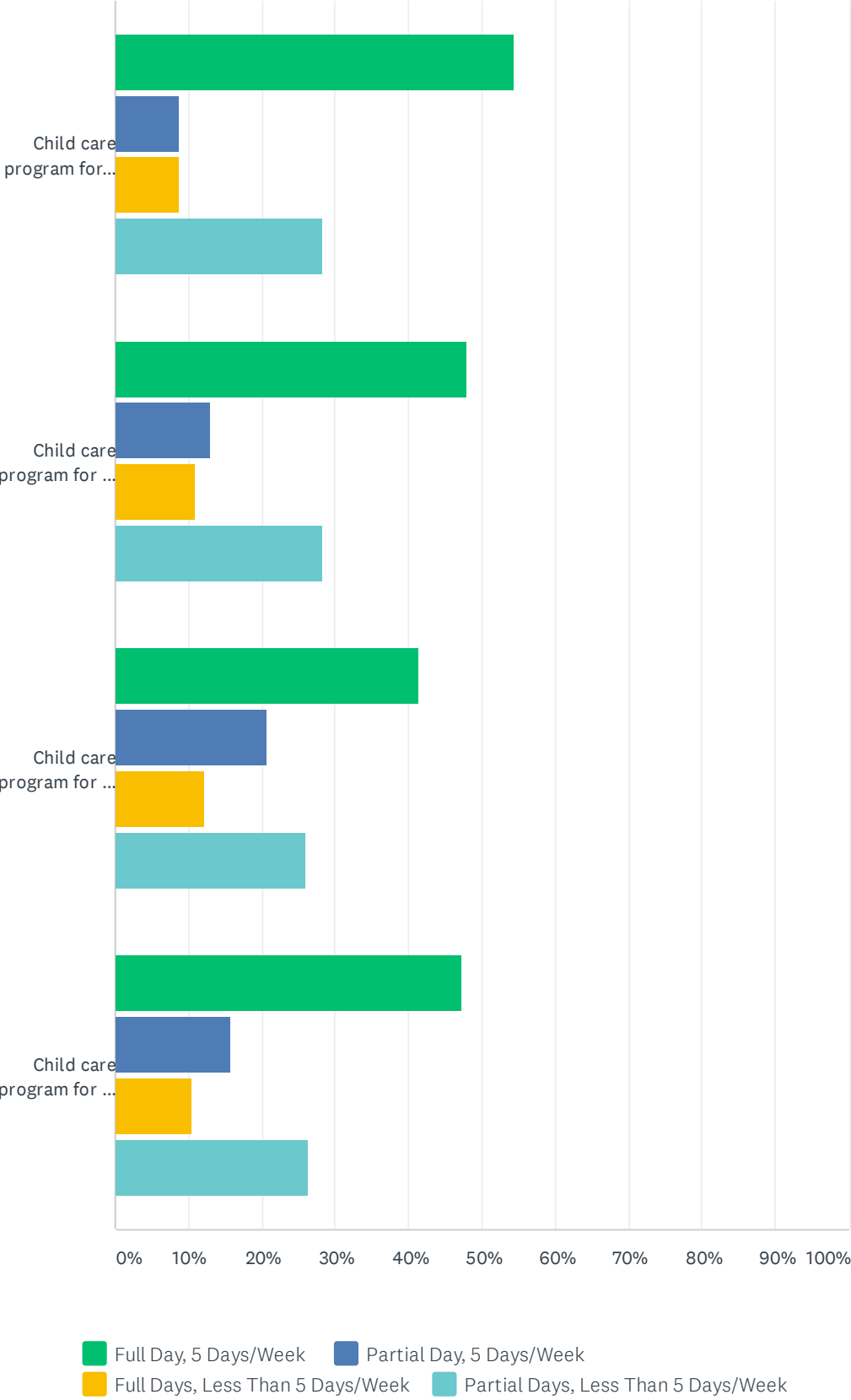

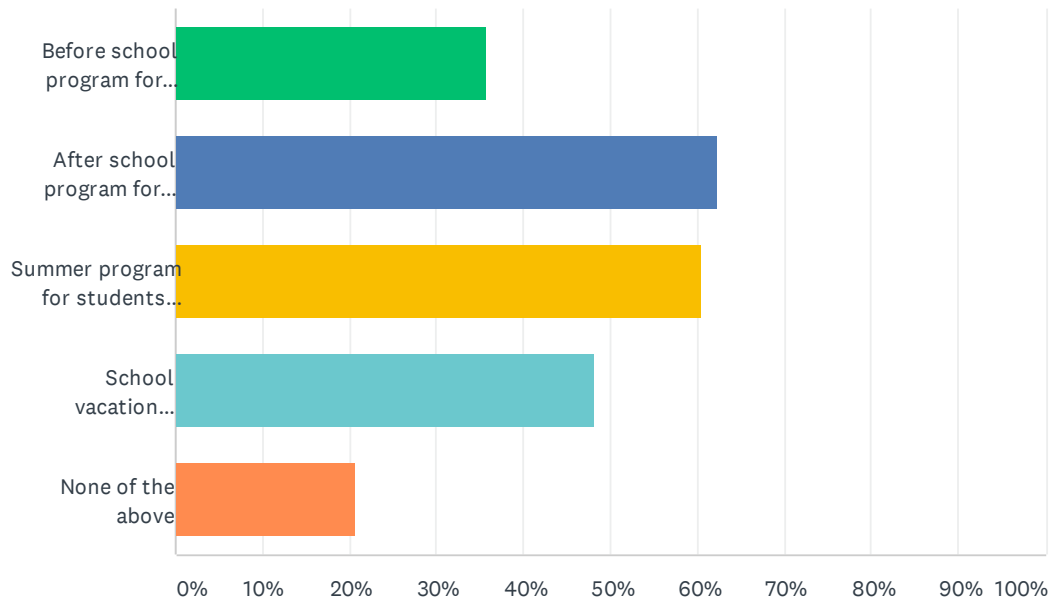

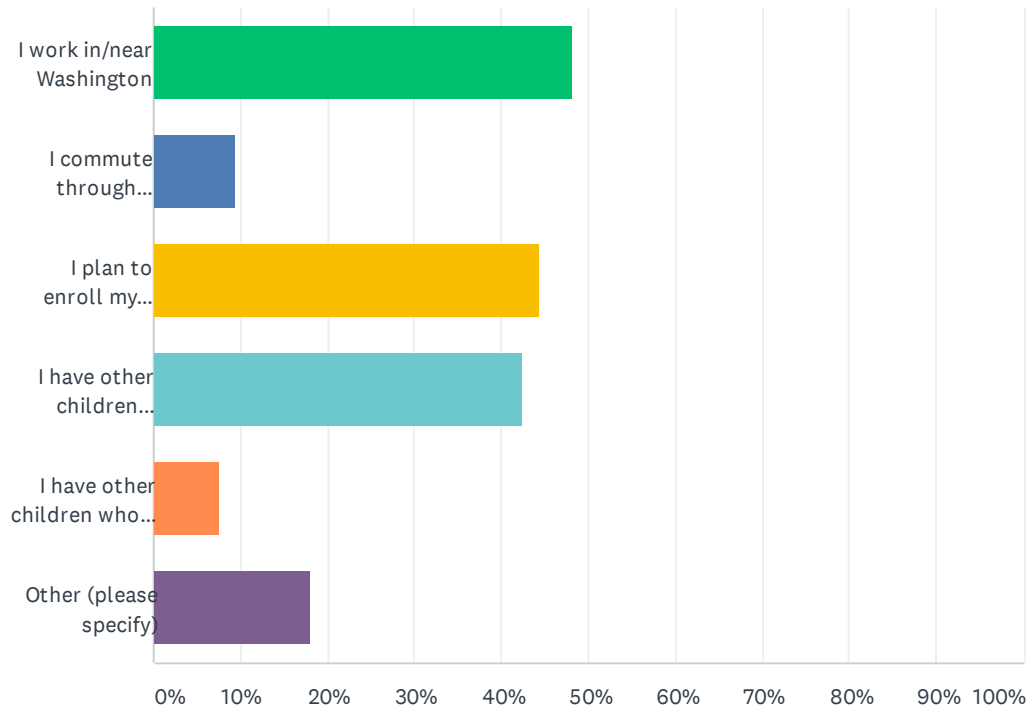

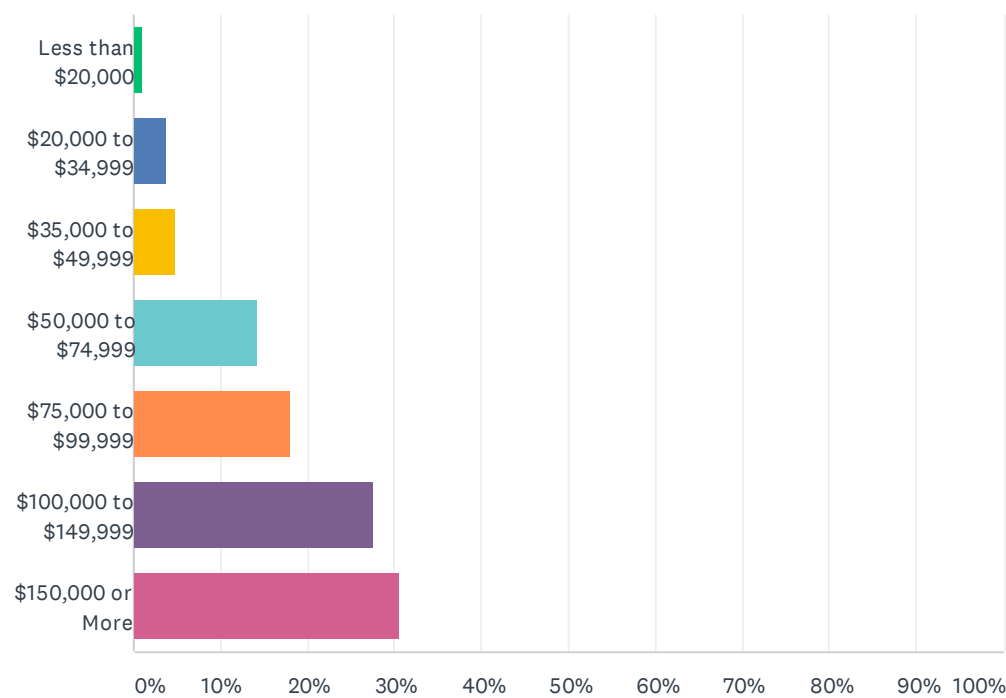
