Public Hearing

The Chair called the public hearing to order at 7:01 p.m. and seated Mr. Hollinger, Ms. Mills, Ms. Woodroofe, and Mr. Rimsky (for Ms. Boyer).

Certificate of Appropriateness Application for 1 Wykeham Road

Mr. Buell read the notice which was published in the Voices newspaper regarding the Certificate of Appropriateness application to construct a black iron safety rail at the Gunn Memorial Library.

The Commission asked Ms. MacLaren, Executive Director of the Gunn Memorial Library, if the library had previously had a safety railing between the parking area and the Wykeham Road entrance. Ms. MacLaren indicated that she was unaware of there being a previous safety rail. Ms. Woodroofe indicated that she believed a previous railing did exist.

Mr. Hollinger asked for clarification on the appearance of the proposed railing. He was informed that the railing would be simplistic, black, and would have a straight edge. The Commission briefly discussed the need for a safety railing at this location.

Mr. Hollinger informed the Commission that he had spoken with Mr. Brinton, First Selectman about the possibility of having maps created for the Historic Districts. He explained that Mr. Brinton had reached out to a surveying company the town had employed in the past, and that it was possible that these maps may be created during the upcoming fiscal year.

Mr. Rimsky provided a brief update on the Delay of Demolition Committee.
