COORDINATOR'S REPORT:

Lisa Easter submitted the following report:

* Hockey:

Lisa has been in touch with Michael Gorra – Family Skate may start on November 17th.

* Fencing:

Parks and Rec has been asked if it would be interested in sponsoring a Fencing Class. If not sponsor, would we "advertise". The classes are held at St. John's Church. The Commissioners agreed to put out information.

* Holiday in the Depot:

- 2) Artistic Irrigation has shut down and winterized the irrigation systems at the park.
- 3) "Fit Together of Litchfield County" has asked that we designate the Park as tobacco free providing free signage, etc. The Commissioners unanimously agreed that smoking does not appear to be an issue and would prefer not to have any additional signs.
- 4) The tennis courts and basketball court have had the cracks sealed for the winter. We have been asked by Region #12 Facilities Department to notify them whenever we have contracted work done to the park so they are aware of who is supposed to be there.
