With A quorum present and alternate Mr. Rimsky seated for Mr. Hollinger. Ms. Averill called the meeting to order at 7:00 p.m.

Public Hearing for The Gunnery, 22 Kirby Road COA Application

The commission clerk read the legal notice for the application that was submitted by The Gunnery, Mr. Cowell CFO, for 22 Kirby Road, for a Certificate of Appropriateness for widening the driveway to the gatehouse, the application is for moving the gate column and reuse the existing light fixture in the moved column and asphalt work that needs to be done due to widening the driveway. Mr. Williams the representative for the property owner explained that two vehicles cannot pass through the current gate column. He showed the commission pictures and of the current positioning of the gate column and a rendering of the purposed work after completion. They want to move the gate column over three feet so that two vehicles can pass through the gate. The same gate will be reinstalled to the gate column and the existing light fixture will be reinstalled, the conduit might need to be changed due to its age. The appearance of the gate column, light and gate leaf will be the same just moved over three feet. Mr. Williams spoke about the landscaping work that will be done around the purposed work site.

Motion to approve the application for a Certificate of Appropriateness submitted by The Gunnery, Mr. Cowell CFO, explained by Mr. Williams for widening the driveway at the gatehouse, moving the gate post three feet, reinstalling the light fixture and gate leaf, at 22 Kirby Road, per the site plan and the written description of the work to be done as submitted on June 19, 2019.
