PUBLIC HEARING

White /6 Parsonage Lane /Extend Certificate of Appropriateness to build garage/studio addition Ms. Gilchrist opened the Public Hearing at 7:35PM to consider the application for a Certificate of Appropriateness submitted by Zemma Mastin White, 6 Parsonage Lane, to extend an existing Certificate of Appropriateness to build a garage/studio addition. She read the legal notice which appeared in The Waterbury Republican on 12/7/11. Ms. Gilchrist seated the members and seated Alternate Krimsky for Mrs. Boyer. Mrs. White was present.

Ms. Gilchrist stated that Mrs. White is present to request an extension of her Certificate of Appropriateness. She invited Mrs. White to speak to the commission. After a brief discussion, the commissioners agreed that since the expiration on C of A's has traditionally been one year, they would stay with a one year extension. Mrs. White said she does not mind coming back in another year if necessary.
