The meeting was called to Order at 7:00pm.

Chairman Solley, Ms. Hill, Mr. Reich, Mr. Werkhoven and Ms. Radosevich were seated for the Special Meeting.

Discussion regarding 101 Wykeham, LLC – Land Tech Compliance Report –

Chairman Solley explained that there would not be much discussion of this topic this evening due to Land Tech's time inability to review and respond to Ms. Purnell, Mr. Barnet and Ms. Hill's comments in time for this meeting.

Ms. Hill stated that she had read Land Tech's first report as well as Mr. Barnet, Ms. Purnell and Attorney Sherwood's letters, and felt that breaking down all of the questions that were asked, adding any more that may be asked, and then submitting them all at one time, rather than in piecemeal.

Attorney Sherwood, representing 101 Wykeham Road, LLC stated that he had submitted all of the documentation he felt would be needed in proving that 101 Wykeham Road, LLC had satisfied all of the Conditions of Approval in order obtain the Special Permit. He clarified that he along with his client would like to work alongside the Commission to make sure all of their questions were answered.

The Commission discussed scheduling a Special Meeting for a future date to review any and all revisions made to the plans, along with answering questions that have been asked.

The Commission asked that Candidates that are elected in the November 2, 2021 election attend this meeting.

The Commission briefly discussed scenarios regarding split lots. Chairman Solley explained that a property owner could petition the Zoning Commission to have the boundary line changed. Ms. Hill added that the Commission had the discretion to ask for screening or fencing if a Special Permit was requested.
